UNDERSTANDING ALZHEIMER'S DISEASE

Alzheimer's Disease (AD) is a progressive neurodegenerative disorder characterized by amyloid-beta ($A\beta$) plaques and neurofibrillary tangles of hyperphosphorylated tau (p-tau), leading to progressive neuronal dysfunction and cell loss.

AD Neuropathologies can remain undetected for years due to the high cost and limited accessibility of traditional diagnostic tools.

These limitations delay diagnosis and intervention, adversely affecting patient outcomes.

CHANGING THE DIAGNOSTIC LANDSCAPE THROUGH **CUTTING-EDGE BIOMARKERS**

Fluid biomarkers are emerging as powerful tools for diagnosing AD.

The CSF A β 40/42 ratio test was the first FDA-approved diagnostic test and serves as evidence of amyloid pathology, supporting eligibility for amyloid-lowering therapy. Blood-based tests provide a further breakthrough in diagnostics by significantly increasing accessibility, while reducing costs and procedural distress compared to CSF or imaging methods.

Among blood-based biomarkers, p-Tau 217 stands out as a transformative diagnostic tool, offering:

Important Considerations

Alzheimer's biomarkers, especially Amyloid-beta 42 (Aβ-42), are unstable and **care must be taken during the pre-analytical phase (collection, labelling, preparation, storage, transport)** to avoid risks to sample integrity and result accuracy:

For plasma biomarkers:

- Ideally, patients will have fasted (8 hours) at the time of blood collection.
- Samples collected in K2-EDTA Plasma (Lavender Top) tubes - no other sample type is acceptable.
- Samples centrifuged in a refrigerated centrifuge and the plasma separated within 6 hours of collection.
- Aliquots must be frozen immediately and transported at - 20°C.

Note: Aliquot tubes must be polypropylene.

Methodology and Biomarkers involved

First consultation due to concern for cognitive and/or behavioral symptoms:

- Loss of short-term memory
- Difficulties in concentration/attention
- Difficulties in recall of names/words
- Difficulties managing finances/paying bills
- Difficulties in orientation in time / spatial orientation
- Confusion with time or place
- Etc...

Blood screening tests to identify common reversible causes

- Complete blood count (Anemia, infection, hematologic malignancy) [NRL Test Code: 21001]
- Comprehensive metabolic panel [NRL Test Codes:16213 (Conventional units); 11023 (SI units)]
- Fasting glucose [NRL Test Code: 6110013 (Conv) 11062 (SI)]
- HbA1c [NRL Test Code: 1101030]
- Thyroid function tests [NRL Test Code: 16293 (Conv) 1103502 (SI)]
- Vitamin B12 and Folate [NRL Test Code: 16435]

Cognitive assessment (any of the below)
